2017 Fundraising Recap - Match Made!

Thanks to the support of generous donors, Kodiak Community Foundation (KCF) successfully met its \$25,000 endowment fundraising goal for 2017.

Donations came in as one-time gifts, monthly recurring donations, and through generous anonymous donors. Pick.Click.Give.generated \$675 for KCF through individuals thoughtfully sharing a portion of their Permanent Fund Dividend.

A number of community members made donations to KCF in memory of the Honorable Judge Roy H. Madsen, who passed away in December 2017. These memorial gifts, in honor of Judge Madsen, will help continue his legacy by supporting local nonprofits and charitable projects.

Making the \$25,000 fundraising goal was especially important in 2017, as The Alaska Community Foundation and Rasmuson Foundation matched donations raised for the KCF endowment, up to \$25,000. Because KCF met this goal, all donations will be doubled, adding \$50,000 to the endowment and helping build a sustainable source of revenue for Kodiak's nonprofit organizations.

For everyone who donated in 2017, thank you! Your donations help build the KCF endowment, which generates annual interest that is then granted out into the Kodiak community. Because of donors like you, KCF was able to provide \$30,000 in grants to 11 organizations, a record for KCF.

2018 fundraising has already kicked off, and KCF is excited to announce that the same matching funds are available if KCF raises an additional \$25,000 this year. It's never too early to make your donation to KCF and help the organization double your impact again in 2018.

With past service on the Board, we're proud of Rotary's work to make Kodiak a better place to live.

When Ed Rasmuson visited Kodiak to promote the idea of a community foundation, I attended and was immediately interested. With many of our present KCF Board members, we officially became an Affiliate of The Alaska Community Foundation in 2013. With five years under our belt I feel the heavy lifting is over. Our KCF endowment fund is more than \$312,000 and we gave \$30,000 last year to Kodiak. Our total giving is well above that,

and many worthwhile endeavors have benefited from our grants, including Senior Citizens, Hospice of Kodiak, our local museums, and other good works. This is done without government funding and is instead made possible through philanthropy and the generosity of our donors.

My personal involvement stems from seeing many people benefit from Kodiak through career and business. Often, people leave during their later years and other places benefit from what Kodiak gave them. Naturally, people will choose to move away in many cases, yet KCF offers a way to give back with a 'gift that keeps on giving.' KCF is a permanent endowment fund. Our principal isn't spent, it's preserved for growth and future giving year after year. I definitely feel like I'm on the ground floor of building something that will last well beyond my lifetime. My parents and grandparents had a 'missionary spirit' of giving to make Kodiak a better place to live, and KCF is a work of faith and commitment where I feel I'm following in their footsteps.

When I say the heavy lifting is over this is also true of our present KCF Board. Each Board member brings a talent and shared responsibility that makes us bigger than the sum of our parts. This is particularly exciting to me as we look to the year ahead. One top priority this year for me as Board Chair is getting our donor wall up in the downtown Convention Center. Grantee Highlight

Kodiak Arts Council

In 2017, Kodiak Community Foundation provided grant funds to the Kodiak Arts Council (KAC) for a community theater production. According to Kodiak Arts Council Director, Katie Oliver, the Kodiak Arts Council's Community Theatre program provides arts opportunities for the people of Kodiak that are both direct and indirect. Opportunities to engage in the arts include performing as actors, singers, dancers, designing, fabricating, painting sets and props, lighting and sound design. Indirect opportunities include audience members experiencing the performance.

Because of funds from Kodiak Community Foundation, KAC was able to host a fall production in 2017, *It Happens Every Summer*. This

romantic comedy was set in 1960s Manhattan, and Oliver said it was an opportunity to showcase comedic talent on the island, and a chance to experiment with new approaches to theater set design. The show included 25 actors, 32 production team members, and more than 620 audience members over the three performances held in November.

It was a busy fall for KAC, and in September they also hosted a set design artist residency with Brian Saylor and Anda Saylor of Anchorage Community Theatre. According to Oliver, the Saylors led a four-hour workshop on the principals and processes of set design and worked eight hours a day with various teams of volunteers designing and constructing the set for the fall production.

"In doing so, KAC significantly increased its human resource capacity for set design and fa brication," said Oliver. "Those skills were also put to use in building elaborate sets for KAC's spring musical, Mary Poppins."

Connecting People Who Care With Causes That Matter

The Kodiak Community Foundation is a permanent charitable fund for Kodiak Island. Grantee Highlight — Threshold Services, Inc.

Threshold Services, Inc. was a 2017 grant recipient of Kodiak Community Foundation and utilized those funds to repair an existing baler. According to Chris Lynch, the President of Threshold's Board of Directors, the baler is an important part of Threshold's operation.

"When plastics, paper, and aluminum are brought to the facility and sorted, they must be baled to go into a 40-foot van for shipping to maximize space in the van," said Lynch.

Lynch said the sorted product is dumped into a bin and fed into a conveyor that carries the product to the baler hopper, where it is compressed into a cube and wrapped in baling wire. Lynch notes this is an integral part of the process, and also the part of the baler that needed repair. It was the portion of the baler that holds the materials in place that broke.

Lynch said the grant enabled Threshold to buy the necessary parts and install them to get the baler operational again. Because of the funds from Kodiak Community Foundation, the organization was able to continue working and shipping products efficiently off the island for recycling.

In addition to its environmental focus, Threshold provides jobs to people with barriers to employment through their core program – recycling.

KCF Hosts Foraker Group Training for Kodiak Nonprofits

On a quiet Friday morning in January, more than 30 nonprofit organization board members and employees packed the multipurpose room of the Kodiak Public Library for a board development training hosted by Kodiak Community Foundation and led by The Foraker Group.

Mike Walsh, Vice President and Director of Public Policy for The Foraker Group, facilitated the January 12 training aimed at increasing competency and performance of board members working with nonprofit organizations. The morning focused on essentials of good governance – reviewing common board member roles and responsibilities and offering discussion and instruction on how to improve. The afternoon was spent discussing recruitment and retention of board members, as well as how to operate effectively on a regular basis. The topics included board meetings, agendas, and effective means to reach consensus on items brought to a board.

According to Kodiak Community Foundation Advisory Board Chair, Craig Johnson, the training "exceeded expectations" and was well received by local nonprofit groups.
